The Kindu Trust is a small Ethiopian child sponsorship charity that has been working for over 15 years to improve the futures of children in Ethiopia.

Through our individual Child Sponsorship Programme, children are able to go to school and improve their opportunities in the future.

Our approach is local, personal and grounded in the needs of the community. To this end, we also run education clubs, income generating activities and sanitation projects for the community.

## **How do I add a gift to The Kindu Trust in my will?**

**If you would like to make a gift to The Kindu Trust in your will the primary way of doing this is by contacting your solicitor to arrange it.**

**If you don't have a will...**

As a will is a formal legal document it is best to work with a solicitor who will advise you and help you to create your will. The solicitors will ask you what kind of gift you want to leave to the Kindu Trust, and for the details of our Charity. These can be found in the box below.

**If you already have a will...**

If you already have a will and wish to amend it to include a gift to the Kindu Trust you can get a codicil. A codicil is a legal document that changes your existing will, your solicitor can help you to draw up a codicil.

**Why use a solicitor?**

A will is a complex legal document, using a solicitor to draw up or amend your will can save a lot of stress for those you leave behind, as well as giving you greater peace of mind.

## How do I make a gift in my will?

A gift in your will, also known as a legacy gift, can be made in three different ways:

### Pecuniary Legacy

This is the simplest way to make a gift to the Kindu Trust. A pecuniary legacy is a gift of a fixed amount of money.

### Specific Legacy

A specific legacy is the gift of a specific asset, for example jewellery, a house, stocks or a rare book. You can give any item you think will be useful or valuable for the Kindu Trust.

### Residuary Legacy

A residuary legacy is what remains after your loved ones get their share and other expenses have been deducted as well as after peculiarities and specific legacies have been paid. It can be the whole or a share of what is left, between 1% to 100%.

## How will The Kindu Trust use my gift?

Your gift will support our existing work and community projects such as our education clubs or support group for mothers affected by HIV.

Each year we help an average of **350 families** get medical care, school materials and financial support. Every week **116 children** receive hot meals from The Kindu Trust, **70 children** access books at our library and **45 toddlers** enjoy a bath with soap at our Playgroup.

You can also specify in your will if you would like your gift to be used for specific purpose. For example, you make a legacy gift to continue the sponsorship of your sponsored child. This is called a 'wish' and your solicitor can help you include this in your will.
